#### A. CALL TO ORDER

The August 16, 2022, Regular Board Meeting of the Village Walk Community Development District (the "District") was called to order at 3:00 p.m. at the Town Center at VillageWalk of Bonita Springs located at 15321 Latitude Drive, Bonita Springs, Florida 34135.

#### B. PROOF OF PUBLICATION

Proof of publication was presented that notice of the Regular Board Meeting had been published in the *Naples Daily News* on October 6, 2021, as part of the District's Fiscal Year 2021/2022 Meeting Schedule, as legally required.

#### D. ADDITIONS OR DELETIONS TO THE AGENDA

Ms. Krizen asked for the board to consider adding her as an Assistant Secretary since she will be running the meetings and signing documents on behalf of the District.

A **motion** was made by Ms. Ray, seconded by Ms. Price and passed unanimously adding Michelle Krizen as an Assistant Secretary, as presented.

#### E. COMMENTS FROM THE PUBLIC FOR ITEMS NOT ON THE AGENDA

Mr. Boucher questioned the pond maintenance, stating that he felt the use of Rip Rap was not a long term solution. The Rip Rap washed away and needs replacement. He opined that there

were other alternatives that would not require frequent replacements. Mr. Wright has not had any conversations with the HOA on this issue, but will reach out to the HOA about alternatives.

#### K. ADMINISTRATIVE MATTERS

Ms. Meneely went over the upcoming meeting schedule of September 20, 2022, October 18, 2022, and November 15, 2022. She stated that the October meeting would most likely include the amended budget. She noted with the November meeting being held two weeks after the election, the current Board Members would attend that meeting with the new Board Members being sworn in at the January 17, 2023, meeting since the December meeting has been deleted from the schedule. There was a consensus to cancel the September meeting and send inquiries for the others.

#### L. BOARD MEMBER COMMENTS

Mr. Hertz asked Mr. Wright about the neighbors spraying Detol. Mr. Hertz read the DDT report and noted that it could kill cats and birds and asked if residents should be concerned about this getting into the lakes. Mr. Hertz would have to look into it since he is not familiar with the product. Mr. Hertz will send an email to Mr. Wright who will look into it and check with water consultants.
