

SUBJECT:	Annual Lake Bank Inspection Recommendations

To supplement the previously provided VillageWalk Lake Bank Inspection Report and Exhibit (RWA files 2024-05-20 VillageWalk Lake Bank Inspection Report (rev 1) and 2024-05-20 VillageWalk Lake Bank Inspection Exhibit (rev 1)) I offer this memo to close-out the annual lake bank inspection program for 2024.

As verbally reported at the May 21, 2024 Regular Board Meeting and based upon this year's report and exhibit, the CDD's lake banks are in good shape and well maintained when it comes to major erosion issues.

My recommendations to the HOA for operations and maintenance purposes are the following:

- 1. Keep doing what you are doing. A good yearly program seems to be in place.
- 2. Based upon visual observation many areas of the community have lake banks that are steeper than the permitted 4 to 1 side slope. It is unknown if the root cause of the steeper lake banks came from new home construction or gradual lake bank recession over time due to erosion. Next year a more quantitative analysis should be conducted to inventory specifically where these areas are located as part of the annual lake bank inspection.
- 3. The HOA should reimplement the provided document titled "VillageWalk Homeowner Association and Community Development District Procedures and Guidelines for Sediment Control, Water Diversion and Infrastructure Restoration.
